A. Legal Advice Pursuant to §38-431.03(A)(1) and §38-431-03(A)(3) Regarding Addendum to Agreement between Kendhammer & Partners, LLP and Chino Valley Fire District for Indemnity Costs

He informed the Board that he used existing indemnity language and added specific language regarding legal fees. The Agency is engaged in multiple contracts with this language. He also consulted with his ethics counsel, Linda Shely. She can provide the Board with names of attorneys if the Board would like legal advice on this or other matters.

Director Pettit suggested Attorney Cornelius provide Linda Shely's contact information should the Board need it.

#### 7. NEW BUSINESS

A. Motion, Discussion, and Action Regarding Review and Selection of Audit Services for Fiscal Years 2018-2020

Chief Tharp stated per the Board's direction, staff solicited bids for auditing services. Four bids were received; however, one was rejected as it arrived after the deadline. The three remaining bids meet the RFP qualifications. He reminded the board that we try to obtain a new auditor every three to four years. Our previous auditor, HintonBurdick's bid was the highest. Chief Tharp asked the Board to make a selection and explained that each auditor has presented a three-year bid for the audits of all three agencies to be completed at the same time.

Bids were: Henry + Horne at \$96,000; ATLAS at \$104,900 and HintonBurdick was \$111,272. HintonBurdick has set all the precedents for moving forward as they conducted the background of the joint venture, performed all of the vetting of the JPA and its setup.




