ITEM I.

Director Jacobs asked why there was an overdraft of \$100,000 and why there was a reconciliation.

Chief Tharp explained that Yavapai County has not been able to provide financial documents for several months. We thought we knew what the numbers were; however, we did not have revenue amounts, because that is recorded by the County Treasurer's office. Chief Tharp advised that there was a \$5 million overdraw of the CAFMA General Fund, which had to be covered utilizing the capital reserve account to be able to make payroll and pay invoices. He explained that the the County Treasurer's office requested the accounts be reconciled back to July 1 to verify their new accounting system. He stated that there were some checks that were charged to our bank account that were not ours and there were revenues attributed to us that were not ours. Notes were made and the issues are being resolved with the County. Chief Tharp stated that the total revenue from July to October was \$7,111,135, and there had been one transfer. He explained that the November reconciliation was received from the County, so that also needs to be approved.

Director Jacobs asked if there was a software link issue with the County.

Chief Tharp explained that the County's system is separate from ours and each agency has their own bank accounts. He stated that if an agency did not have savings, they had to rely on issuing warrants, and warrants accrue interest the same as a credit card would until the balance is paid. Instead of spending warrants and accruing interest for CAFMA, because we knew there was money, we transferred funds from the saving account until the funds could be transferred to CAFMA.

Director Jacobs asked if CAFMA was in a deficit to make payroll.

Chief Tharp stated that we are doing okay because of the savings account and if the Board approves, we will make the transfer tomorrow and we'll have a surplus of about \$4 to \$5 million to get us to the next tax collection. Funds will be moved back to savings.
