#### NEW BUSINESS

A. Presentation, Discussion and Acceptance of Fiscal Year 2018 Audit Report as Presented by Henry+Horne

Brian Hemmerle with Henry+Horne presented the Fiscal Year ending June 30, 2018 Audit and informed the Board that it was a clean opinion; the financial records provided were free of any misrepresentations. There also were no issues noted when comparing the taxes levied to debt. He explained the new auditing standard for reviewing other post employment benefits separate from pension. The liability increased \$200,000 above the pension cost which shows on the CAFMA audit.

Chief Tharp encouraged the Board to review Management's Discussion and Analysis, and he informed them that there will be a more in depth review of the financial standing of all agencies next month.
