#### NEW BUSINESS

A. Motion, Discussion, and Action Regarding Board Meeting Schedule

Chief Freitag explained to the Board that the State has changed legislation as it relates to fire authorities. Agencies that make up the Authority only need to meet quarterly. One recommendation from staff was to alternate meetings and hold meetings when the meeting is either in Chino Valley or Prescott Valley. Budget meetings may need to be held more often. Yavapai County was requiring a monthly board approval to transfer funds. He explained that once the budget is approved; that is approval for the transfers.

Chief Tharp has not received a response from the County Treasurer's office. Inter fund transfers are allowed within the same agency by statute. If we are transferring to outside accounts, the County has some concern. With the new statute, it allows the transfer as long as the parties agree.

Chief Freitag asked Chief Tharp to reach out to the County Treasurer; he is not asking for Board approval today.

Attorney Cornelius advised the Board that the current IGA allows for the Boards to meet regularly; however, they are not required to meet monthly.

Director Pettit confirmed that the budget process begins in April with June being the final budget approval. She suggested meeting quarterly in quarters one, three and four, with additional meetings during budget development in quarter two. She suggested making it clear so that a calendar may be published.

Motion that the Chino Valley Fire District Board meet in the calendar year in February, April, May, June, August, and December, with any special requests in any other month will be called separately.

This will take affect upon approval from Yavapai County.
