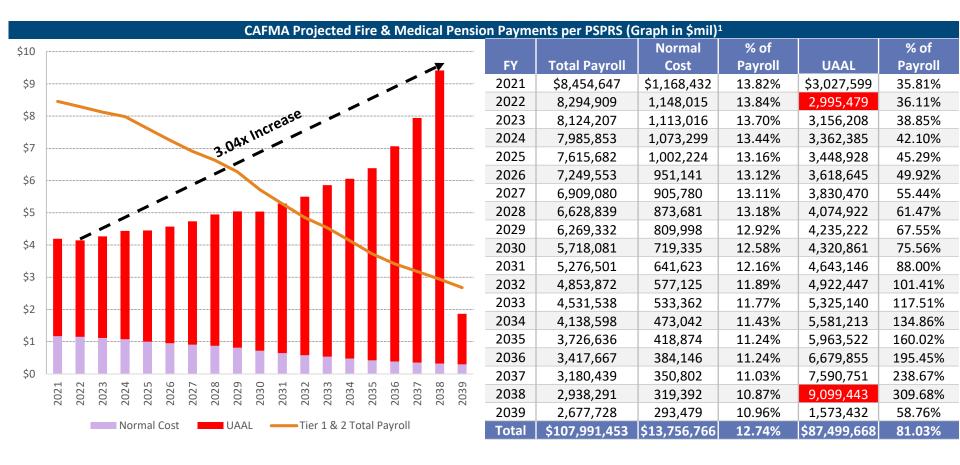

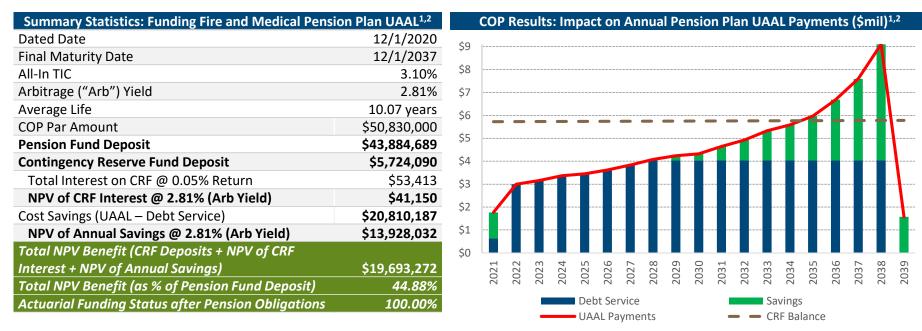

Issuing pension obligations to fully fund the Authority's unfunded pension liabilities could allow the Authority to generate significant net present value benefit totaling \$19.69 million (44.88% of pension fund deposit), including establishing Contingency Reserve Funds ("CRFs") while leveling out year-over-year payments

- Replacing the Authority's upward curving pension UAAL amortizations with level debt obligations could reduce the cost and life of the Authority's pension liability, and we expect the level debt amortization in particular would be well-received by rating agencies
- Our structure is designed to produce level debt service but without exceeding the current UAAL amortization in any year
- As summarized below, *this scenario could produce \$19,693,272 of total NPV savings*, including \$13,928,032 from reduced annual UAAL payments, \$5,724,090 from the creation of a Contingency Reserve Fund, and \$41,150 from interest on the CRF assumed at 0.05%

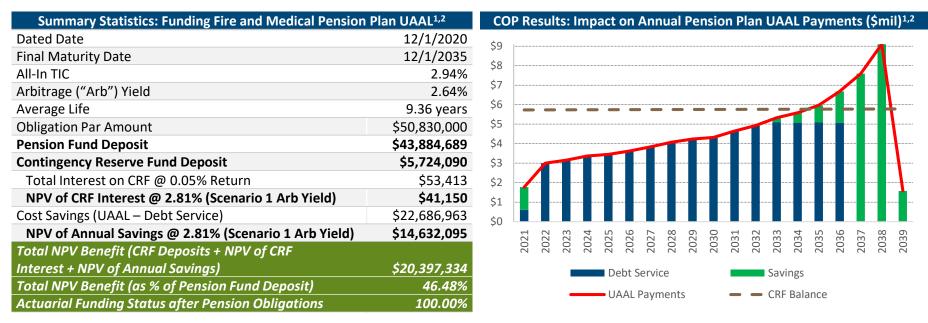

Expanding on Scenario 1, the Authority could shorten the amortization of the obligations, resulting in faster debt payoff, greater savings, a lower borrowing cost, and likely favorable rating agency views

- While Scenario 1 produces exceptional savings, Scenario 2 expands these savings by shortening the final maturity to 15 years
- In comparison to Scenario 1, this structure would result in higher annual debt service payments, but also *a lower borrowing cost, greater* projected cash flow and NPV savings, and shortened pension-related liabilities
- We expect rating agencies will favorably consider the highly conservative nature of this structure, which both levels the annual cost of the unfunded pension liability and shortens the final maturity
- Our structure is designed to produce level debt service but without exceeding the current UAAL amortization in any year
- As summarized below, *this structure could produce \$20,397,334 of total NPV savings*, including \$14,632,095 from reduced annual UAAL payments, \$5,724,090 from the creation of a Contingency Reserve Fund, and \$41,150 from interest on the CRF assumed at 0.05%

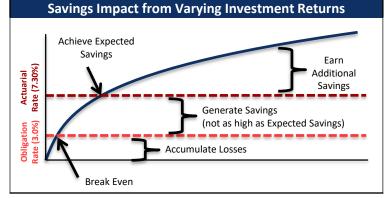

Pension Obligations: Risks

STIFEL

- Pension obligations carry three distinct types of risks: i) actuarial risk, ii) market risk, and iii) other risks
- Actuarial Risk. Any retirement system's independent actuaries calculate projections for plan assets and liabilities, and these projections are premised on a variety of assumptions such as investment returns, payroll increase, COLA, mortality, early retirement, and benefit payments
 - Annual employer contributions are calculated based on these assumptions
 - Any revision or variance from these assumptions will alter projections and required contributions, regardless of the issuance of pension obligations
 - Actuarial risk is inherent to all pension funds, and all projections of future contributions and payouts



- Market Risk. The primary risk associated with pension obligations is long-term investment return performance
 - The obligation rate is impacted by market risk at the time the obligations are sold, but is locked in after that
- Other Risks. Pension funding obligations have numerous risks including, but not limited to, variance from the anticipated investment return, payroll increase, COLA, mortality, early retirement, covered payroll and other assumptions contained in the actuarial reports, CAFR and other documents
 - All references to expected savings are for potential savings and are based on achieving rates assumed in actuarial reports, CAFR and other documents
 - Issuing pension obligations could result in savings that are greater or less than stated in the analysis, or could result in a loss
 - Potential savings vary from year to year; Actual savings or losses and the success of the pension obligation transaction cannot be known until the amortization of the final pension obligation maturity
- Additional risks may also exist

Mitigating Risks: Contingency Reserve Fund

Key Decision Points: • How can the Authority help mitigate risks associated with COPs?



The Authority can apply a portion of obligation proceeds to create a Contingency Reserve Fund that helps manage market and actuarial risks associated with COPs

- What? Helps mitigate risks associated with year-over-year volatility in investment earnings as well as changes in actuarial assumptions, such as assumed rate of return, COLA, mortality
- How? Use a portion of COPs/lease proceeds to establish an initial balance in CRFs for the Fire and Medical Plan
 - Apply a defined portion of ongoing year-over-year budgetary savings from the pension obligation (difference between what UAAL payments would have been versus debt service costs) to continue funding CRF
- Why? In years where investment returns do not meet defined/established benchmarks, and/or changes in actuarial assumptions cause a significant change in projected annual payments, the Authority can draw on the CRF to smooth the budgetary impact of funding additional contributions for the newly created UAAL
- Why not? Negative carry of issuing additional debt to fund an upfront deposit

Rules for Investment of Proceeds. This is akin to permitted investment guidelines for reserve/escrow funds

• Proceeds should only be invested in liquid and/or short-term products to ensure prompt availability of funds

Rules for CRF Draws. While there may be greater flexibility to accord broader rules for draws on an CRF absent COPs/lease proceeds, in practice, permitting draws for any/every possible increase in payments could deplete the balance too soon

- The Authority may consider establishing a minimum fund balance threshold before which draws on the balance of the CRF could occur
- Draws may also be restricted to draws of investment income only, while the balance is untouched
- Establish periodic funded ratio thresholds, where CRF balance above a pre-defined level is drawn to supplement ARC

Rules for Contingency Replenishment. Could use ongoing pension obligation savings or use *sell the float* on other Authority held funds for periodic inflows

- The Authority must also consider mechanisms to build up and/or maintain the CRFs balance by securing a stream of steady cash flow beyond the initial deposit
- This entails defining the revenue and investment sources for fiscal transparency, and redirecting investment returns in excess of an established benchmark to the Contingency Reserve Fund

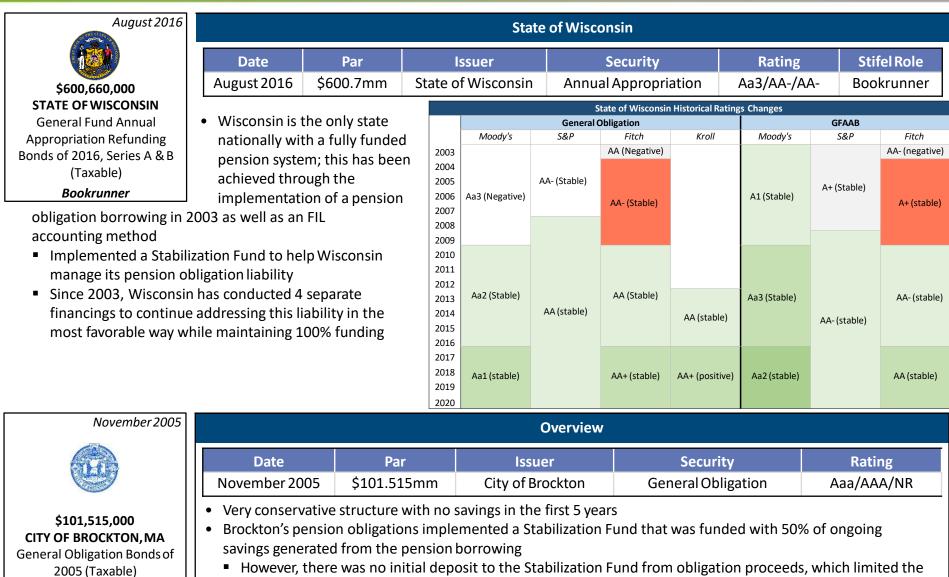

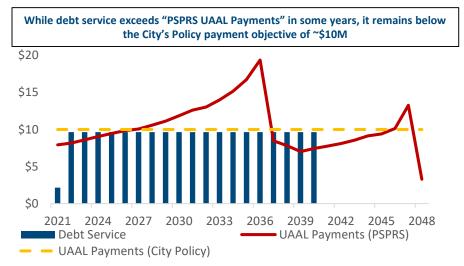

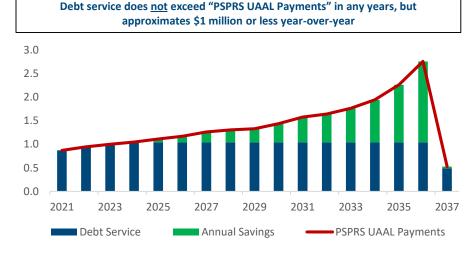
A pension obligation financing is a tailored tool that for helping drive a given municipality's desired policy objectives

City of Flagstaff^{1,2} Gila County^{1,2}

- Flagstaff is issuing Certificates of Participation to fully fund its pension obligation. Certificates are secured by a leasehold interest in various city-owned assets
- The City already had a policy in place for making "supplemental" UAAL contributions every year (up to \$10 million available in total annually) to accelerate the repayment of its UAAL before the PSPRS amortization period
- The City also wanted to create budgetary certainty with level year-over-year costs and provision for future contingencies
- Given the City's policy of accelerated UAAL repayment, the City can shorten this debt to 19-20 years, while still generating savings and creating CRFs



- Gila County's policy objectives include ensuring debt service costs associated with a pension borrowing do not exceed PSPRS projections for any given year
- They are also interested in creating a more level payment profile to shave down the cliff presented by escalating PSPRS UAAL payment projections
- Finally, Gila County has existing cash reserves that they are exploring as a potential source for establishing a pension liability management reserve fund that can help insulate against market and actuarial risks associated with pension costs in general and pension obligations in particular

Chief's Report By Fire Chief Freitag

It has been a busy month despite travel still being very limited due to COVID. We have become adept as using the virtual platforms like Zoom, however there is something that is lost when you cannot meet face to face. I do believe that once we can meet in person again we will balance it with Zoom meetings as it can enhance communication when used as part of a hybrid model.

We will be putting the finishing touches on our new studio for podcasts and YouTube video production on the 22^{nd} of this month. Our plan is to record several longer podcasts with an accompanying video component before releasing the first one. Given it can take some time to produce a quality product, we want to have some waiting in the queue rather than having an expansive period of time in between shows. We will also use the platform to review *The Review* each week. This should enhance our ability to communicate, especially with those who do not like to read.

We continue to work with multiple states as part of our special district coalition to ensure districts are recognized in future COVID-related funding. There is political support for including us, however politics are preventing an actual aid bill from moving forward.

As the president of the AFCA, I continue to work with our committee to develop a statewide Fire Chief's Academy. We have a draft curriculum based on feedback from the Texas Chiefs, the LA County Chiefs, and our Senior Leadership Academy. However, we plan to conduct a survey through both the City Managers Association as well as the League of Towns and Cities. We want their feedback to ensure we are on the right path providing education in areas they deem important for Fire Chiefs. Additionally, we would like their support for the program. We will also be meeting with the Life Safety Council in the Valley to ensure we solicit feedback and support from the metro agencies. It will take some time before we have the program ready for launch, however taking our time and ensuring we have the right program for the state will ensure we have a quality product.

We have been working closely with Prescott since the CAFMA Board gave us direction to sign on as interveners in AMR's bid to adjust their response times as outlined in Certificate of Necessity (CON) 62. The hearing has been pushed back to a yet to be determined future date. In its place, the court will hold a prehearing on the 21st. Chief Niemynski and I will attend via conference call as there will not be an in-person option.

I would like to say how proud I am of the work our Training Division and Training Cadre have been doing throughout the COVID situation. Despite recommendations for shutting the world down, our training staff have continued to offer quality training opportunities both for our personnel and the region. They have measures in place to ensure the safety of all attendees as well as instructors, short of mandating masks. The instructors from ISFSI complimented our personnel, as well as our staff, upon completion of the NFPA 1403 program stating that we have one of the finest facilities and groups they've had the privilege to work with. Additionally, Tempe Fire Chief Greg Ruiz complimented our staff and personnel on our commitment to

training as well as our regional focus. I believe this feedback says a lot about who we are as CAFMA, and the quality of our personnel.

When an organization loses 50% of its senior leadership, it can cause a few challenges. I can state without hesitation that we have not had any issues. Assistant Chief Feddema and Assistant Chief Rose have stepped into their positions and in a very short time have made positive changes. I know they have had some challenges, but both have approached them with the professionalism and expertise we would expect. Our team has transitioned and we have already formed strong bonds. I credit our success to two things; firstly, John and Cody are high quality professionals. Secondly, the time we had for transition is not something most agencies get to enjoy, and I can say without a doubt that it paid dividends for CAFMA.

The Wage and Benefit Study is due sometime in October. Our plan is to ask the company performing the study to present a summary to the Board at either the October or November Board meeting. We continue to work closely with Labor, and look forward to developing a plan once the results of the study are received. As not all of our employees are part of the Union, discussion will take place through our Wage and Benefit Committee.

We have created an internal-only posting for the open Assistant Fire Marshal position. I hope to finalize the process in the coming weeks. Additionally, we have hired two folks for the open positions in Fire Prevention. Both have a level of education and training in Prevention which allowed us to bring them on as Fire Inspectors rather than at the apprentice level. This will save us some time in training, and hopefully allow us to catch up on some of the work we need to complete. That said, due to COVID, we have suspended most business inspections until the first of the year. Many businesses are closed, or have strict mandates for entry. This will also provide the time we need to get our new inspection program and software running as well as provide training for those who will utilize it in the field.

Administration By Assistant Chief Tharp

We have received notice that the Wage and Benefit survey has been distributed to multiple agencies (as agreed upon by the Wage and Benefit Committee) and we have already received 14 completed surveys and are following up with a few more. What this means is that the designated timeline for the completion and compilation of the date is on track for the end of October. This will allow the agency to process the results and begin crafting a plan for the future to address all areas of concern. Obviously, this will be a joint effort by management, labor and the CAFMA Board of Directors to put together a financially viable and responsible plan for the future. We are looking forward to the results and the opportunity to work on this for our employees and organization.

At the last PSPRS Board of Trustees meeting, the board unanimously approved some changes that will have an impact on our employer contributions (percentage and total dollar amount) and the resulting UAL (Unfunded Actuarial Liability). I heard the struggle from the board members regarding the choices that they needed to make and the impact it would have on employers and ultimately, they made the hard, unpopular choice. They elected to lower the assumed payroll growth rate from 3.5% to 2% by a half a percent a year... and then reevaluate the assumption when it reaches 2%. Many organizations have received little in payroll growth, 1-2% per year on average, so stating that 3.5% payroll growth was occurring to the fund was an overestimation. Also, for any future unrealized gains that would just be "lumped on top" of the current amortized UAL of 16 years, it will be recalculated at its own amortization period of 15 years. This particular aspect will prevent some of that "ramping" of employer contributions that we were looking at in years 10-15 of our remaining amortization period. While this will help in our future "losses" when our return on investment (ROI) does not meet or exceed 7.3%, it will not help this past fiscal year – where they are predicting a minimal or 0% ROI and we are having a good year (2013) drop off of the seven year smoothing calculation. Bottom line, we will see an increase in our employer contributions, but are optimistic that our fiscal predictions will accommodate the increase.

These changes will allow our current "debt" with PSPRS to remain somewhat "constant" (but not go away) and will allow us to move forward with a couple of possible tools to address our \$49 million in unfunded liability. Chief Freitag will discuss Certificates of Participation (COP) that Towns and Cities can currently use, but I will be focusing on our agreed plan of contributing \$250,000 each fiscal year (starting next year) towards our UAL. I will offer an opportunity to place those funds into an IRS 115 Trust that will provide this Board the control and opportunity to utilize these funds in the best way for the future of CAFMA. Additionally, if the voters approve legalizing marijuana in Arizona in November, we will see some additional funds that may help in the future funding of our pension liabilities. We will discuss this more at the CAFMA Board meeting.

Events requested/attended by CAFMA: No events were attended this month due to COVID.

Monthly Safety Tip:

The weather has been hot and dry with very little monsoon moisture. Below are some action Items to Improve Your Home's Survivability:

- **REMOVE** leaves, pine needles, and other flammable material from the roof, gutters, and on and under the deck to help prevent embers from igniting your home.
- SCREEN areas below decks and porches with 1/8" wire mesh to help prevent material from accumulating underneath.
- **COVER** exterior attic and soffit vents with 1/8" wire mesh to help prevent sparks from entering your home.
- ENCLOSE eaves to help prevent ember entry.
- **INSPECT** shingles or roof tiles. **REPLACE** missing shingles or tiles. **COVER** ends of tiles with bird stops or cement to help prevent ember penetration during a wildfire.

Tips for Landscaping Around Your Home

- **REMOVE** dead vegetation and other flammable materials, especially within the first five (5) feet of the home.
- **KEEP** your lawn hydrated and maintained. If it is brown, cut it down to help reduce fire intensity.
- **PRUNE** tree limbs so the lowest branches are 6 to 10 feet above the ground to help reduce the chance of fire getting into the crowns of the trees.
- MOVE construction material, trash, and woodpiles at least 30 feet away from the home and other outbuildings.
- **DISPOSE** of branches, weeds, leaves, pine needles, and grass clippings that you have cut to reduce fuel for fire.

Operations By Assistant Chief Feddema

Unfortunately, this year continues to provide operational challenges. CAFMA resources have been deployed locally and to several other states due to the lack of moisture, and it doesn't show any signs of improving. Maintaining staffing has been important and we have limited the number of personnel who can leave based on our local fire danger. This has been complicated by COVID because this has also influenced staffing levels.

We have seen a decline in the number of personnel requiring COVID testing. We have also seen a decline in the number of times crews come in contact with patients that are experiencing flulike symptoms. We are still following our protocol to limit exposure to personnel on scene. The challenge has been that most of the personnel who have been tested reported exposures due to family members who have been positive. In this situation we have worked with each member to get tested before they return to work. This has been a balancing act; however, Chief Niemynski has been working with each potential exposure to get them tested before they return.

I am currently working with the Arizona State Fire Training Committee and the Arizona Fire Chiefs Association to put together a Battalion Chief's Academy. The program will be hosted in Tempe this year and we are working to finalize the presenters. While many outside training activities have been shut down, our training division has worked hard to provide opportunities. They have also worked to update the accommodations for Engine 540. Engine 540 has been in service since August and has already helped add capacity to the responding resources in the Prescott Valley area. They have been responding to calls for service, supporting training activities at CARTA, covering crews that are attending training, and moving up to cover stations. There have been some challenges relating to the response area; however, we continue to work with PRCC to refine this. We are also working with Michael Freeman to review the data collection so we can monitor the effectiveness of the resource.

EMS Report By EMS Chief Niemynski

We have filed 23 formal complaints with AZDHS for the month of August. The number of complaints has come down quite a bit due to the CAD to CAD link getting the dispatch information to Lifeline's dispatch center in a quick manner. This is a good development. There are still problems, but overall the rate is down from a high of 60-80 per month. We responded our Rescues twice due to a response delay from Lifeline. We transported one of the patients with our Rescue to YRMC.

The Sim Man manikin has been refurbished and is back at CARTA. This will enable our EMS Instructor Cadre to provide the most realistic simulation training for the students taking classes at CARTA. We have several training classes scheduled in the next two months at CARTA for Paramedics and EMT Recertification.

We are working with Handtevy to build CAFMA-specific protocols within the Handtevy product. Several of our Paramedics are reviewing the product for accuracy. Once accepted, we can start the hands-on training and then go live. It looks amazing so far.

The annual maintenance and calibration for all the District's Lifepak monitors is complete. We still need to send in two of our units since they were deployed on wildfire assignments during our inspection day.

Planning and Logistics By Assistant Chief Rose

Facilities

The fence project will finally be kicking off on Monday, September 21 at Station 59. The project is expected to take approximately two weeks to complete. Once it's completed we will be working with Tech Services to get the access control system up and running for the new gate.

The generator has been shipped for the Mt. Francis upgrade. The hope is to have the installation completed on Mt. Francis by the second or third week in October. Once completed, the old generator will be relocated and installed at Station 72. The gas line needed at station 72 for the generator is expected to be completed by the end of next week.

Station 57 has had the stucco work completed and painting of exterior of the facility is currently underway.

A new storage building has been ordered for Station 53 and is expected to arrive in 6-10 weeks. This is to replace the three older, smaller buildings that currently exist there and were in need of some repair and relocation. The new one will be placed on the concrete area to the west of the existing buildings.

CARTA – We recently installed a washer and dryer in the bay of the building to accommodate Engine 540 needs. Also, the new gate to be installed at the main entrance has been ordered and is expected to be completed by the end of October. As part of this project we will be working with Tech Services to install solar equipment that will not only provide a charging source for the batteries on the new gate, but also provide the power for the access control system being installed.

Warehouse

In addition to the everyday work, there were a few extra projects completed at the Warehouse this month. We were able to successfully outfit the new Utility with assistance from Fleet personnel. This process was moved to the Warehouse from Fleet last month and it was the first time that the Warehouse had the responsibility of outfitting apparatus. Overall, it went well and we were able to get the truck completed in one day and ready for in service. We are now in the process on gathering inventory for the two new Type 1 engines which will be ready for outfitting in the near future.

Norm Rorick was married to Andie Smith this past Saturday. Congrats Norm and Andie!! Norm will be on vacation for two weeks, returning to work on September 28.

We continue to work with Tech Services on ironing out issues with our ASAP software that we use for inventory and tracking of all items in the warehouse. We have been able to make some significant improvements over the past month and look forward to further improving this for our

use. This will also be a significant help when we conduct our first full annual inventory in late spring of 2021.

<u>Fleet</u>

Projects:

This month Fleet Maintenance was able to complete the new Battalion 6 truck and the new Utility 61. Both units are now in service in Battalion 6. In a continued effort toward fleet continuity, these vehicles were built to match Battalion 3's truck and Utility 53 as closely as possible. Our next priority project is the outfitting of the two new Type 1 engines. One of these units will go to station 58 and the other to station 61. There is a lot of work involved in getting these units ready for frontline service. Fleet is watching closely as we prepare for service to see what work needs to be performed in-house and what we can have completed at the factory as these units are built to maximize efficiency and minimize in-service work. Currently, all of the striping has been installed and MDT mounts are being fabricated for these two new engines. We also took delivery of a new UTV and that unit is being prepped for in-service.

Maintenance and Repair:

We had many vehicles come and go for services, annual pump tests, and small repairs. Wildfire season has been busy, so we have had a lot of vehicles come in the shop for post-deployment inspections. We perform these inspections every time one of our vehicles is sent off district for a substantial assignment. This way we can be sure we are sending out our personnel in safe, reliable vehicles each time they are assigned. Some of the more in-depth repairs are as follows: WT-63 was completed this month. It was in for rear axle walking beam bushing replacement. We ended up replacing the entire walking beam suspension assemblies as well as performing an annual service and pump test. WT-53 was in for an intermittent electrical voltage drop out on cranking. This job required many hours of troubleshooting to figure out the underlying issue and then a rewiring of the ignition voltage side of the transmission control. Currently, we have Engine 62 in for service and repairs. Once completed we will be bringing in Engines 61 and 63 for their services.

Update:

Engine 51 has had its new instrument gauge cluster system installed. We are waiting on a call back from electrical engineering at Spartan to guide us through an illumination issue in the new gauges. Engine 58 has been down at Cummins for some time. After installing a new long block engine assembly they had multiple issues with the turbocharger assembly. Their engineering team has been working to come up with a repair. The last update from Cummins was that the parts will be there this week and they should have the unit completed soon.

Technical Services

Technical Services is in the middle of some major projects. These include:

- Access Control: Converting Warehouse, Administration, and Station 58 to new access control solution. Expected completion by the end of November.
- Network Infrastructure: Removal of legacy microwave equipment from Mount Francis and PRCC. New equipment to be installed before the end of October. Legacy equipment is being donated to DPS (see additional Board item).
- Network Infrastructure: New diesel powered generator being installed at our Mt. Francis site. This is a joint project with Facilities.
- The Review "podcast" is in prelaunch phase. More to come soon.

E. Monthly Division Reports from the Fire Chief and staff in regard to current activities of the Fire Authority and the status and progress relating thereto. Any item discussed in the Division Reports is subject to discussion and direction by the Board; no action will be taken.

Chief Tharp reported that the City of Flagstaff has just paid off their PSPRS unfunded liability through a Certificate of Participation (COP), similar to a bond. Flagstaff was able to raise enough for their unfunded liability as well as an additional 15 million for potential future benchmarks. Fire Districts do not currently have the authority to use a pension bond, for that legislative changes would need to happen. CAFMA is undergoing a study with Stifel and PSPRS to see what the savings might be to the taxpayers if agencies were able to go that route. He added that a COP must be budgeted in the annual budget; it is not like a general obligation bond that is in addition to the tax rate.

Clerk Packard inquired as to whether or not PSPRS would continue adding unfunded liability if CAFMA paid the current amount off. Chief Tharp responded yes; that while paying it off would solve our immediate issue, our Tier 1 and Tier 2 issue, it would not solve the unfunded liability issue for Tier 3.

Chief Feddema reported that the 40-Hour Engine is off and rolling. Data is being collected, the small bugs are being worked out, and it is going well so far.

Director Zurcher inquired as to the status of the Engine 58 repairs. Chief Rose reported that a fault in the turbo of Engine 58 caused a delay in its return. The engine should be back in service next week. The 40-Hour Engine now has a space set-up at CARTA.

Chief Feddema stated on behalf of Chief Parra that trainings are moving forward with COVID-19 precautions in place. The Engineer Academy will take place in September.

- 4. NEW BUSINESS
 - A. Motion, Discussion, and Action Regarding Approval for Fire Chief and Agency Counsel to Participate in Administrative Hearing Related to Proposed Certificate of Necessity

Amendments by Life Line Ambulance, Inc.

Chief Freitag reported that the City of Prescott recently approached CAFMA stating that they were going to intervene in Lifeline Ambulance's Certificate of Necessity (CON) hearing relating to CON 62, which includes CAFMA's area. Their intent is to improve the response time standards to which Lifeline will be held within the CON. Lifeline's current standard is set at arriving on scene within 10 minutes 70% of the time, and Lifeline is suggesting that be increased to arrival within 10 minutes 80% of the time. He stated that neither 70% nor 80% are response time standards recognized anywhere in the country; 90% is the standard. Prescott would like to be on record with the Department of Health Services (DHS) stating that 80% is not a nationally recognized, or reasonable, standard.

He continued, the City of Prescott has been negotiating a contract with Lifeline/AMR for about two years now. Chief Light inquired as to whether CAFMA would be willing to collaborate by going together to DHS. Prescott's City Council has voted unanimously to move forward and has given direction to their attorney and Chief Light to file a notice of appearance and the all documents necessary to outline the City's concerns. Prescott already has the language prepared, which would need to be amended for CAFMA's area, but Attorney Cornelius recommends filing a notice of appearance and signing as joiners.

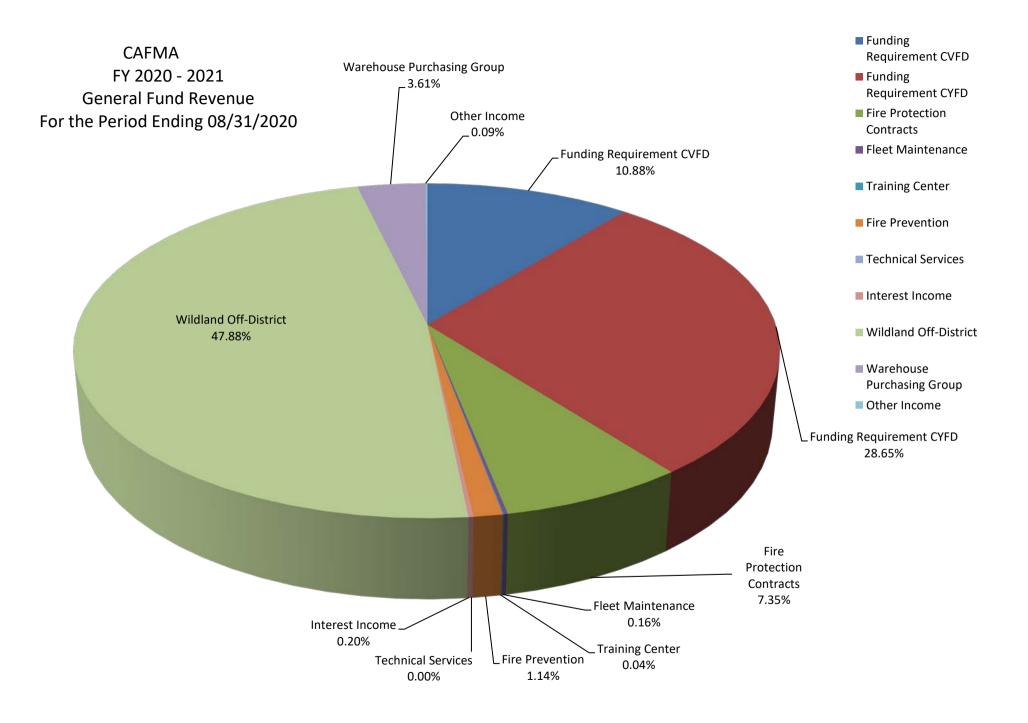

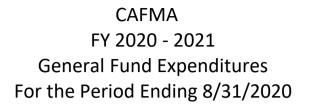

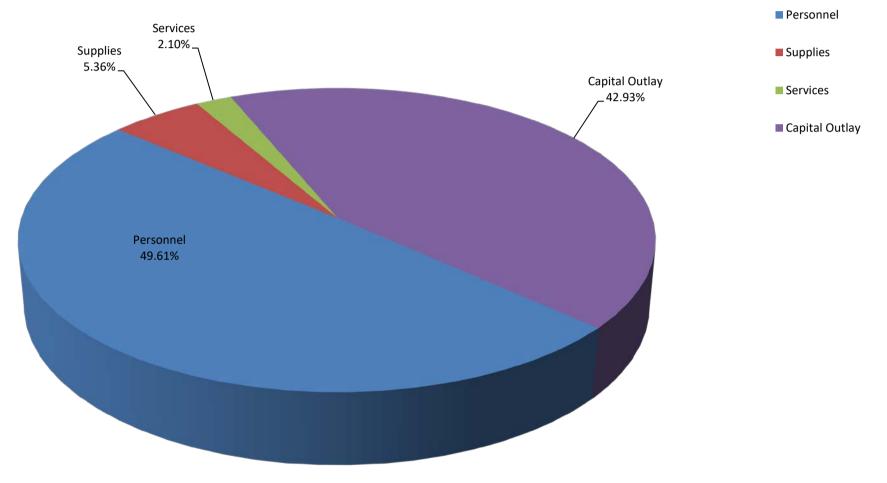

FIRE PROTECTION SERVICES AGREEMENT

This Fire Protection Agreement is made effective _____, between the Central Arizona Fire and Medical Authority, a political subdivision of the State of Arizona, hereinafter referred to as "AGENCY" and _____, hereinafter referred to as the "Applicant." The property under consideration is described as:

IT IS THEREFORE MUTUALLY UNDERSTOOD AND AGREED AS FOLLOWS:

1) <u>Purpose</u>. AGENCY shall provide fire protection and limited emergency medical services under the terms of this Agreement.

2) <u>Duration and Renewal</u>. The effective term of this Agreement shall be from through **June 30, 2019.** The provisions of this Agreement shall renew automatically on July 1 of each year for consecutive one-year terms, unless either party pursues termination of the Agreement pursuant to Paragraph 11.

3) <u>Services Provided</u>. Fire Suppression, Emergency Rescue, and limited Emergency Medical Services (collectively "Emergency Services") will be provided under this Agreement. Unless the Incident Commander (senior AGENCY Officer present) requests additional help, AGENCY shall provide a standard response as determined by AGENCY dispatch protocols on each emergency call from the Applicant, subject to conditions below.

It is intended that the Emergency Services provided under this Agreement shall be made available to the individuals residing at the property described in the Preamble above (the "Property") or invitees of said residents (collectively, "Service Recipients") in conjunction with the above-referenced Property irrespective of whether the Property is owner-occupied or leased. While the Applicant shall be responsible for all fees assessed under this Agreement, AGENCY also reserves the right to invoice any actual Service Recipient for the services provided under this Agreement, according to the fee schedule adopted by AGENCY, as amended from time to time. Said billing shall be in addition to the service fee charged under this Agreement.

In providing services under this Agreement, AGENCY reserves the right to involve such other jurisdictions and EMS or suppression service providers as it deems necessary, consistent with its then current protocol. No assurances are made as to

whether, or to what extent, any such third party providers will respond. Applicant and Service Recipients may be responsible for any additional charges assessed by such other service providers.

Applicant herein acknowledges that AGENCY alone will determine its response to any given incident and that AGENCY alone will determine the number of units and personnel responding to such incident. Applicant further acknowledges that such response is subject to, among others and without limitation, any unforeseen circumstance, a major fire, other accidents, conflicting concurrent calls, reduction in force, road closure, poor road conditions, acts of God, or other situations in which there is a shortage of manpower or equipment. Applicant understands that the response time will likely be extended beyond that which might be regularly expected elsewhere within the jurisdictional boundaries of AGENCY by reason of the distance to and isolation of the Applicant's Property, the limited manpower available, access limitations, road conditions, and the other calls within AGENCY that may take priority, and Applicant hereby consents to the same. In addition, Applicant acknowledges and agrees that AGENCY's response and effectiveness may be limited by a lack of adequate water supply.

Applicant acknowledges and agrees that AGENCY may, in its sole discretion, give priority to other emergency calls either within AGENCY's jurisdictional boundaries or outside AGENCY boundaries, potentially causing a delay in response time. Further, Applicant acknowledges and agrees that AGENCY may, in conjunction with any call to the Property, respond with insufficient equipment or manpower on occasion, either by reason of limited manpower, equipment availability, resource allocation, or by reason of the limited information having been made available to AGENCY in conjunction with the determination of the appropriate response.

Applicant hereby acknowledges that no assurances are given or warranties made as to the response time or service level that will be offered, and agrees to hold the AGENCY harmless from and indemnify AGENCY for any and all damages which might be incurred by Applicant, Service Recipient, to Applicant's Property or to any third party's property or person, including that of any Service Recipient, by reason of extended response times, reduced equipment or manpower response, the decision to involve other service providers, failure to involve other jurisdictions or service providers, AGENCY's decision to allocate resources elsewhere either inside or outside of AGENCY's jurisdictional boundaries, the allocation of manpower or equipment, or other operational decisions which might result in delay or additional loss of life or property.

Further, Applicant acknowledges and agrees that AGENCY shall not be liable for the negligent act or omission of any third party service provider. Applicant also agrees that AGENCY is under no obligation to transport any Service Recipient. Applicant acknowledges that AGENCY does not hold a Certificate of Necessity and does NOT provide ambulance or non-emergency transport services, and that transport services are typically provided through a third party. Applicant, Service Recipient, or both, shall be solely responsible for any and all expenses associated with any transport services utilized by either. 4) <u>Response Time</u>. AGENCY shall make reasonable efforts to respond to Applicant's emergency calls in a manner consistent with then-current agency protocol, subject to the terms and conditions set forth in this Agreement. Applicant hereby acknowledges that response times are subject to variations due to existing weather conditions, road conditions, travel distance, traffic conditions, property identification, conflicting responses, equipment and manpower availability or allocation, and access to Applicant's Property. Applicant acknowledges that because of the substantial distance involved, the minimum response time likely to be experienced by Applicant may exceed that of other recipients within the jurisdictional boundaries of AGENCY, and that no assurances are given by the AGENCY as to what ISO rating might apply to the Applicant's Property.

5) <u>Routing Information</u>. Applicant agrees that it shall provide AGENCY with current routing information to Applicant's Property in a form acceptable to AGENCY Fire Chief, and will endeavor to inform all occupants of subject Property of the proper procedures to follow in case of fire.

6) <u>Access</u>. Applicant hereby specifically acknowledges that standard access roads sufficient to allow AGENCY fire equipment to reach the scenes of emergency calls are a significant factor in AGENCY's ability to respond to emergency calls within a reasonable and expeditious time. If access roadways are not maintained by other public service agencies, the responsibility of providing and maintaining adequate access rests solely with Applicant. Applicant hereby agrees to hold AGENCY harmless from and to fully indemnify AGENCY for any liability or damages arising from any delay which might occur by reason of limited, inadequate or poorly maintained access, inadequate address or access description, or failure of Applicant or the Property to comply with applicable fire codes, building codes, zoning codes or recommendations or requirements made by any agency or AGENCY.

Applicant hereby grants to AGENCY the right of ingress and egress and to enter upon Applicant's Property for purposes of conducting inspections to determine accessibility, and to observe any other matters which may affect AGENCY's ability to provide services under this Agreement. Nothing herein shall be construed as requiring AGENCY to make any such inspection, or to require that AGENCY report to the Property owner in regard to any accessibility issues.

7) <u>Compensation; Calculation; Payment</u>. As consideration for AGENCY's provision of Emergency Services under this Agreement, Applicant shall pay to AGENCY a sum (the "Service Fee") equal to the amount which would be paid if the Applicant's Property was located in and taxable by the respective fire district (either the Central Yavapai Fire District or the Chino Valley Fire District) which would otherwise contract to provide such services to Applicant at that fire district's then current tax rate, any applicable bond debt servicing rates, plus an administrative fee equal to \$50.00 as modified from time to time. The Service Fee shall be owed to AGENCY by Applicant even if there is no current county tax assessed on the Property: by reason of the fact that the property is considered to be non-taxable; because no net assessed value has

been established; or for any other reason. In that event, for the purpose of calculating the Service Fee to be paid by the Applicant, 10% of the full cash value as indicated by the county assessor's office may be used as the assessed value, or if the full cash value is not available, the value of the property shall be established by way of appraisal conducted by a duly-licensed real estate appraiser provided by and solely at the cost of Applicant.

If the property is appraised, the assessed value will be 10% of the appraisal. The then current fire district tax rate shall be applied to said property value, plus any then-applicable bond debt service rates and an administrative fee equal to \$50.00. If for some reason the current assessed value information is unavailable, then the Service Fee under this contract, as renewed, will be equal to the Service Fee charged for the immediately preceding service year, plus 10%, until such time as the current property value information becomes available, at which time the fee for the then-current year shall be recalculated and an adjustment to the Service Fee made.

Payment shall be due when this Agreement is signed; alternatively, payment arrangements may be approved in the sole discretion of AGENCY for quarterly payments with the first payment being due and payable simultaneous with the execution of this Agreement and thereafter on the first day of each subsequent quarter. Any payment not received within 30 days of the due date will be considered in default and may result in the termination of this Agreement. For the initial term of the Agreement, the parties agree that the fee shall be **\$**«**F17**», but that such fee may be prorated (based on 12 months).

In the event of termination of this Agreement due to non-payment by Applicant of the agreed Service Fee within 30 days of due date, Applicant must reapply for Emergency Services pursuant to a new Agreement. In such event, the only option for payment under such new Agreement shall be for payment of all monies due in full at the time of execution of the new Agreement; other payment arrangements will only be considered upon renewal of the Agreement after completion of the initial term of the new Agreement.

The Service Fee paid to AGENCY by Applicant pursuant to this Agreement shall be considered earned by AGENCY when paid, and shall not be conditioned upon or modified by reason of the number of responses made by AGENCY to the Applicant's property during the term of this Agreement. While Applicant shall be responsible for all Service Fees assessed under this Agreement, AGENCY also reserves the right to invoice any actual Service Recipients for the services provided under this Agreement according to the then-current fee schedule adopted by AGENCY, as amended from time to time. Said invoice shall be in addition to any Service Fee due under the terms of this Agreement.

8) <u>Insurance</u>. Applicant shall provide AGENCY with a current certificate of liability and hazard insurance, together with the name and address of insurance agent, name of insurance company providing coverage, and insurance policy number.

9) <u>Waiver and Disclaimer of Liability</u>. Applicant agrees that AGENCY shall not be liable for any consequential damages to Applicant or any Service Recipient, including but not limited to any lost income or profits suffered by Applicant or any Service Recipient. In consideration of AGENCY's agreement to provide services under the terms of this Agreement, Applicant agrees to hold AGENCY harmless and hereby releases AGENCY from and indemnifies AGENCY for any and all claims, demands, liability and causes of action that may arise as a result of AGENCY providing the services described herein. Applicant specifically agrees to hold AGENCY harmless from, in addition to the foregoing, any claims, demands, liability or causes of action which might arise out of AGENCY's inability to provide, or any delay or limits in providing services, due in whole or in part to the conditions spelled out in Sections 3, 4, 5, and 6 of this Agreement.

10) <u>No Third-Party Beneficiaries.</u> This Agreement will be for the benefit of the parties named herein only and shall not be construed as having been entered into for the benefit of any third party.

11) <u>No Warranties.</u> Nothing herein shall be construed as a warranty by AGENCY against damages, whether to real property or personal property, which may result by way of fire, injury to a person, by accident or any other emergency occurring on Applicant's Property.

12) <u>Limitation of Damages.</u> In the event of breach or non-performance by AGENCY, Applicant's sole remedy shall be limited to the termination of this Agreement and refund of any unearned fees for that current contract year, the parties hereto having agreed that said fees are a reasonable amount of damages. This limitation of damages shall bind, without limitation, Service Recipients, family members, legal representatives, assigns and successors in interest of the Applicant. The waiver, hold harmless and indemnification provisions of this Agreement are for the benefit of AGENCY and shall survive the termination of this Agreement.

13) <u>Termination</u>. Either party may terminate this Agreement by thirty (30) days' written notice of termination delivered to the other party at these addresses:

For AGENCY:

For Applicant:

In the event of termination of this Agreement after the Applicant has paid the required payment due for that term, AGENCY shall return funds to the Applicant prorated on a per day basis for the period after the date of termination.

In the event Applicant sells the subject property or otherwise disposes of the same, this Agreement will terminate immediately upon notification from the Applicant of same; provided, however, that the indemnification requirements imposed on Applicant under this Agreement for incidents occurring during the term of this Agreement shall survive the termination hereof. Nothing herein shall prevent AGENCY from negotiating a new emergency services Agreement with the new owner of the subject property.

14) <u>Cancellation Due to Conflict.</u> AGENCY may cancel this Agreement pursuant to the mandates of A.R.S. §38-511.

15) <u>Severability</u>. If any provision of this Agreement shall be held to be unconstitutional, invalid, or unenforceable, it shall be deemed severable; however, the remainder of the Agreement shall not be affected and shall remain in full force and effect.

16) <u>Fire Code Compliance</u>. Applicant hereby specifically acknowledges that all operations and activities, as well as new construction, and remodel of structures when applicable, will be in compliance with AGENCY's adopted Fire Code.

The undersigned warrants to AGENCY that the Applicant has the power to enter into this Agreement and that all necessary acts have been taken to enter into this Agreement.

The purpose of this policy is t_T o identify the purpose and function of the Policy Committee.

II. SCOPE

This applies to all Policy Committee Members.

The Policy Committee shall consist of the following representatives:

- Fire Chief
- Battalion Chief (or designee)
- Labor Representative (2)
- Assistant Chief of Administration / Executive Administrative Director
- Administrative Member Representative (2)
- Planning and Logistics Representative
- Operations Member Representative (3)
- Fire Prevention Representative
- Alternate Members

III. POLICY

A Policy Advisory Committee shall be established to study issues and make policy recommendations to the Board of Directors. Representation on the Committee shall be drawn from all levels of the organization.

The Policy Committee shall operate under the provisions of the Arizona Open Meeting Law and Robert's Rules of Order. The Policy Committee will serve as an advisory committee to the Board of Directors on all items that fall within the scope of the current policy manual. Items of policy will be presented to the Board of Directors after a majority vote by the Policy Committee. A dissenting opinion may be included in the presentation if the dissenter wishes.

The Policy Committee shall operate under the provisions of the Arizona Open Meeting Law and Robert's Rules of Order. The Policy Committee may also discuss items related to operational procedures and make recommendations to the Fire Chief for consideration.

The Committee may meet on a monthly basis; however, due to the wildland season and reduced attendance, meetings may be suspended annually during the months of June, July, and August as directed by Fire Chief.

Selection

The representatives shall be selected by their peers. <u>Each representative will</u> then appoint an alternate.

Term

Each Committee member will serve at least a two-year term with the exception of the Fire Chief and the Assistant Chief of Administration. Positions will be open for selection in April of each year.

Attendance

The Policy Committee will meet as needed. Committee members must attend 66% of the meetings and not miss more than <u>three (3)</u> consecutive meetings to remain a member of the Committee. If a member is removed from the Committee <u>due tofer</u> poor attendance, the alternate shall assume the regular position and another alternate will be selected as outlined above.

Officers

Officers of the Committee shall consist of a chairperson and a clerk. These officers will be elected from the membership of the Committee at an election during the regular meeting in April of each year. If either office is vacated for any reason, the Committee shall elect an interim officer to fill the position until the next annual election.

At the direction of the Committee, tThe Clerk shall produce agendas, packets, and minutes for Policy Committee meetings-at the direction of the Committee. The Clerk may be a non-voting member appointed by the Chairperson.

Voting

Each position on the Policy Committee has one vote. Members must be present to cast a vote. An alternate may cast a vote if a regular member is not present at the meeting.

Policy Review

All policies, including the organizational chart, will be reviewed every $\underline{\text{five (5)}}$ years.
