6. NEW BUSINESS

- A. Motion, Discussion, and Action Regarding Approval of Resolution 2020-09 and FY 2020-2021 Final Budget and 5-Year Projection

**Chief Tharp reminded the Board that this is the same budget that was presented and tentatively approved at last month's meeting. He noted that the NAV is expected to decrease after next year. The Agency is being fiscally conservative due to COVID-19, and is attempting to be proactive by providing projections that are purposefully low. He stated that the tax rate remains at \$3.25 for the years going forward.**

**Chief Tharp informed the Board that once the budget is approved, the Board has to approve certification pursuant to that statute. It states that the organization is not incurring any debt or liability in excess of what the organization is allowed to collect.**

- C. Motion, Discussion, and Action Regarding Approval of Resolution 2020-10 Assignment of Equity for FY 2021

**Chief Tharp explained the assignment of equity as it relates to the audit process. The Chino Valley Fire District will be assigned 19.74% funding equity assignment based on the JPA.**

**Attorney Cornelius recommended that the Board amend the motion to include the Fiscal Year 2021 Budget in the amount of \$4,919,237, and revenue should be assigned at 19.74% based on the funding requirements of the JPA.**

**Director Pettit read Resolution 2020-10 into the record.**

**Chief Tharp stated that this rate is specific to the bonds issued to the Chino Valley Fire District and that all of these funds were used in the last fiscal year for the remodel of Station 61. The Agency has approximately 13 years left of bond repayments. The rate continues to decrease over time and it will get to a point where the tax rate will drop significantly.**
