Chair Zurcher called the meeting to order at 5:00 p.m.

5. CALL TO THE PUBLIC

In accordance with A.R.S. §38-431.01(H) the Central Arizona Fire and Medical Authority Board has decided to allow public comments as time permits. Those wishing to address the Board regarding an issue within the jurisdiction of this public body may do so by completing a *Call to the Public* form and submitting it to Staff. Speakers are limited to three (3) minutes, but may submit written comments for Board records. Call to the Public shall not exceed 30 minutes per meeting. Board members shall not discuss or take legal action on matters raised during an open call to the public, but may ask Staff to review a matter or may ask that a matter be placed on a future agenda.

Mr. Eliot Pickett addressed the Board with a request to build a fire station in the Mingus West area. He stated that response times and service levels in the Mingus West and Legend Hills areas have been discussed amongst residents, and he presented a petition with signatures to the Board.

Chair Zurcher directed Staff to respond to the petition and to place the matter on a future agenda. He requested that Staff prepare a brief synopsis including potential timing and placement of a new station in Mingus West.

8. OLD BUSINESS

A. Discussion and Possible Approval of Resolution 2021-09 Authority to Proceed with the Certificate of Necessity (CON) Application Process

Reconvened into Open Session at 6:02 p.m.

Chief Freitag provided an update on extended ambulance response time issues, including that Level Zero is still a daily occurrence. He provided a few instances from radio traffic earlier in the day, including that a Prescott Fire engine reported that a family gave up waiting for the ambulance to arrive and had to take their personal vehicle. Another call had AMR / Life Line Ambulance (AMR) marking themselves on scene when they were not. Though the problems persist and worsen, AMR management continues to emphasize that no problem exists, and the Department of Health Services (DHS) continues to agree with AMR.

Director Mills asked for further explanation regarding the term 'Level Zero'. Chief Freitag explained that he is being told that there are 4-5 staffed ambulances working the entire area, so when all five ambulances are on calls and another call comes in, AMR is then at Level Zero: no ambulances available. Chief Niemynski reported that seven ambulances is the goal AMR is attempting to meet, but Staff has not seen seven available ambulances.

Chief Freitag shared that he listened to recent radio traffic and gave an example of a time when AMR went Level Zero and four calls stacked up. This is the type of example which led to the family from a Prescott Fire call to take their own personal vehicle to the hospital, as previously mentioned. He also listened to radio traffic where AMR was not reporting Level Zero because they had dispatched an ambulance from Wickenburg and from Williams; the ETA being an hour and 16 minutes. Director Mills stated that Wickenburg and Williams are not in the Quad City area. Chair Zurcher noted that both Wickenburg and Williams fall within Certificate of Necessity (CON) 62, AMR's CON that includes the Quad Cities.

Chief Freitag reminded the Board that when AMR goes Level Zero, there is an engine crew waiting on a non-critical scene, and sometimes two engine crews, if a Rescue must be dispatched. He shared an example of an engine crew waiting 51 minutes for an ambulance.

Director Mills inquired as to whether or not AMR must separate interfacility transfer units from emergency response units. Chief Freitag answered no, and gave examples of costs for interfacility transports compared to 911 transports; AMR makes more on interfacility transports. He noted that only AMR can originate interfacility transports in the region. He added that Yavapai Regional

Medical Center (YRMC) testified last week on behalf of Priority Yavapai that the hospital was receiving transport ETAs of 10 or more hours. YRMC has had to fly patients between facilities because ambulances are not available. Dignity has tried to obtain a CON twice, but the State has denied them both times.

Chief Freitag advised the Board of emails between John Valentine, AMR Regional Director, and Rob Barth, YRMC's Emergency Services Director, obtained through a public link to the Priority Yavapai hearings, wherein Mr. Valentine requests that YRMC stop asking questions about the number of units in the system and response times. Chair Zurcher encouraged the Board and public to visit CAFMA's website, www.cazfire.org, to view the emails. He further advised the Board regarding correspondence between Mr. Valentine and himself.
