- A. Discussion and Possible Direction to Staff Regarding Chino Valley Fire District Board Vacancy

**Chief Freitag reminded the Board that a vacancy was created when Director Mills submitted his resignation. He requested the Board's direction regarding posting for the vacancy and scheduling a special meeting for candidate interviews.**

**Direction to Staff is to post as soon as possible with an application due date of close of business July 20, 2022. Interviews will be held on July 25th at a special meeting beginning at 4:00 p.m. at CAFMA the Administration building.**

- B. Discussion and Possible Approval of Resolution 2022-06 and FY 2022-2023 Final Budget and 5-Year Projection

**Chief Tharp explained that the final budget before the Board has not changed since last month's tentative budget approval. He further explained the State of Arizona is requiring all Fire Districts to use a new form for budget submissions which auto-calculates the District's 5-year projection. He reported that the new form does not correctly calculate the District's 5-year projection, and there is not a way to edit the formulas, so Staff has also included the Agency form that has been used in previous years. He also reported notifying the County Finance Division as to the difficulties.**
