## **NOTICE OF MEETING**

A. Discussion and Possible Approval of Resolution 2023-04 and FY 2023-2024 Final Budget and 3-Year Projection

**Chief Tharp stated that there were a few reductions in the CAFMA budget that led to a reduction of approximately \$2,000 for the Central Yavapai Fire District. The total budget for CYFD is \$26,180,028; this is not the amount allocated to CAFMA as some funds are retained for items such as election expenses, legal expenses, auditing fees, and board member expenses.**

**Chief Tharp explained that the equity assignment follows the GASB-14 statement for joint venture accounting, which allows us to assign liabilities and equity back to the individual agencies. It is not based on the Net Assessed Valuation (NAV) of the District, it is based on the amount being contributed to CAFMA for each agency.**

This resolution allows us to transfer revenues reported by the Yavapai County Treasurer's office on a monthly basis, not to exceed the \$26,146,528 that is assigned to CAFMA. That is not the total budget amount that was approved, that's just the amount assigned to CAFMA. If there are excess funds received at the end of the fiscal year, we would bring a request to the board for approval to transfer those excess funds to CAFMA or to the Capital Reserve Fund.**
