B. Semi-Annual 2023 Alarm Summary

Chief Rose presented the 2023 Alarm Summary.

Chief Freitag stated that we have had a significant increase in call-volume over the past five (5) years. He added that we have seen a bit of a plateau due to the economy, however, we are still trying to catch up to the 36% increase we experienced previously.

## A. Board Member Reports

Chair Zurcher reported that he rode with Engine 58 for National Night Out earlier this month. He added that he also visited Station 63 and commented that the new Turnout Room was done well.

## B. Division Reports

Chief Freitag shared that Chief Feddema is not present tonight as he is working with the outside panel members for Battalion Chief Testing tomorrow. He added that he had a brief meeting with Prescott Regional Communication Center (PRCC) today about County-Wide dispatching. The County has asked if we could help fund a study regarding new dispatch options. He stated that governance is one of the big concerns as we own four (4) of the five (5) dispatch channels, and pay 24% of the costs to support them.

Director Anderson agreed that we need the position, and thinks we need to hire for this sooner rather than later. Chief Freitag answered that he believes there may be funds available for this. As soon as we can find the money in the budget, we will come back to the Board for approval.

D. Discussion and Possible Approval Regarding Purchase of One New Battalion Chief Truck, One New Brush Truck, and One New Community Relations Vehicle Not to Exceed \$285,000.00 For All Three

Chief Rose advised the Board that these vehicles are in the Capital Plan. We are looking for approval; however, we have not found these vehicles. Board approval would give Fleet Manager Scaife the ability to locate and move to purchase these vehicles. He added that the Brush Truck will likely come in at less than what we have budgeted; however, the Battalion Chief truck will come in at a higher amount than budgeted. The Community Relations vehicle would actually become a Prevention vehicle, allowing their gear to be stored outside the vehicle as part of our cancer-mitigation efforts.
