6. NEW BUSINESS

- A. Discussion and Possible Approval of Resolution 2023-03 and FY 2023-2024 Final Budget and 3-Year Projection

**Chief Tharp reported that the 3-year projection is based on the report we are required to provide to the State. He further commented that the budget includes a 3-cent increase to the Chino Valley tax payers. Clerk Dobbs clarified that they were provided a 3-year projection vs. a 5-year projection. Chief Tharp explained that by law, we have to provide a 3-year projection; he further commented that we have provided 5-year projections in previous years, but we've found that the last two years always change and are not in alignment with what was originally projected; he gave inflation as an example of what affects these projections. He added that the projection shows a 3-cent increase for the following 2-years.**

i.e. board member expenses, legal expenses, and election expenses.
