F. Discussion Regarding Statutorily Required Training

Secretary Chute requested that if the committee members have not completed the required training, to please do so and forward the completed forms to her. Per Attorney Apodaca, PSPRS is starting to audit files checking for compliance.

Member Rorick thanked Secretary Chute for making the process easier by including links in the email that went out to committee members.

Chair Zurcher then asked if he needed to complete the committee training for this board since he is in compliance for another district board. Attorney Apodaca suggested that he complete the training for this committee as some of the training is slightly different.

G. Discussion Regarding Citizen Board Member Requirements

Secretary Chute shared that this is a compliance piece. There are two citizen board member requirements: at least one member has to reside in the district, the other requirement is that one member have a Human Resources (HR) background. Member Robison confirmed he lived in district while Member Rorick replied that neither of them have an HR background.

In response, Attorney Apodaca said that ideally, statutes state that both requirements be met. A member with the HR background does not have to live in district, and in the future, this may be something to consider as a new member is brought in. We should try as best we can to comply but it is not always the case.
