A. Investment Account Update - Freedman Crossett Investments

Ms. Cindy Crossett joined the meeting on Teams. She shared that as of October 2nd, the current value of the investments is at \$220,522.07 with a net investment balance of \$173,371.98 including deposits and withdrawals. The account is doing exceptionally well and has a gain amount of a little over \$47,000. The investment is conservatively invested with about 61% in bonds, which had previously not been doing well; however, with interest rates coming down, the values will go up. She would not recommend any changes at this time.
