A. Investment Account Update - Freedman Crossett Investments

Ms. Crossett joined the meeting remotely via Teams. She provided a summary of the financial report dated April 9, 2025. The account is slightly down from the last quarter but still doing well in gains. The first quarterly distribution took place on April 1, 2025 which the statement balance reflects. The account is not overly invested in stocks and due to market volatility, she does not recommend any changes right now.

Director Ebarb asked if she has ever recommended changes to the investments.

Ms. Crossett responded that when the account was first transferred over, it was all in government bonds; the bylaws

were changed, and a portion of the investment was reinvested in some stocks.
