- Auction opens at 8:00 a.m. on August 4, 2025, and closes at 5:00 p.m. on August 14, 2025.
- All vehicles and equipment sold “AS IS”, and all sales are final. CAFMA is not responsible for ANY defect or malfunction found after the sale is complete.
- All bids will be considered, even if under the suggested minimum value.
- Bids may be submitted online by using the link or QR code below. In-person or mail-in bids will be accepted at CAFMA Administration, 8603 E. Eastridge Drive, Prescott Valley, during regular business hours: Monday-Thursday, 7:00 a.m. – 5:00 p.m.
- In-person or mail-in bids must include the vehicle number or lot number you are bidding on, the bid amount, your name, and phone number.
- The outside of the envelope must be clearly marked with “vehicle bid” or “equipment bid” and the vehicle or lot number the bid is for. One bid per envelope, please.
- Bids will be opened on August 18, 2025 @ 8:00 a.m.
- A CAFMA representative will contact the highest bidders on August 18, 2025. If contact cannot be made within 24 hours of the bid opening, we will move to the next highest bidder.
- Payment must be made to CAFMA Administration within 5 business days of bid award notification. Cash, cashier’s check, or credit/debit card are accepted. Please note, a 3% fee will be added to credit/debit card payments to cover processing fees.
- All lights and sirens will be removed from vehicles before pickup unless purchased by another fire agency or fire contractor.
- Arrangements for vehicle and/or equipment pick up can be made with the Fleet Manager after payment is made. Vehicles and/or equipment must be picked up within 7 business days after payment is made.
- Vehicle records and test drives will be available to the public on Thursday, August 7, 2025, and Thursday, August 14, 2025, from 9:00 a.m. – 3:00 p.m. Please call CAFMA Administration at 928-772-7711 to schedule an appointment to view vehicle records or test drive vehicles.
